Payment Information

Due Dates and Invoice Details

- Fees are due by the first day of the term including the additional charges as detailed in our Terms and Conditions.
- An invoice with fee details will be sent by the Bursary before each term begins.

Payment Method

Direct Debit Options

- Termly Payments:
 - Fees paid on the first day of each term, three times a year including the additional charges.
- Ten Monthly Payments:
 - Annual tuition fee divided into ten monthly instalments.
 - Collected on the third day of each month from August to May.
 - Additional charges are collected separately in September, February, and May.
 - Should your Direct Debit fail, the option to pay the fees by instalments, either ten or twelve, will be removed and the fees will be due on the first day of term or immediately whichever is earlier.
- Twelve Monthly Payments:
 - Annual tuition fee divided into twelve monthly instalments.
 - Collected on the third day of each month from August to July.
 - Additional charges are collected separately in September, February, and May.
 - Should your Direct Debit fail, the option to pay the fees by instalments, either ten or twelve, will be removed and the fees will be due on the first day of term or immediately whichever is earlier.

What's Included in the Fees

School lunches, all curriculum related books, materials and some curriculum related external trips. Fees are inclusive of personal accident insurance. VAT will be added where applicable.

Exclusions

Uniform, sports kit, instrumental music tuition, home to school transport service (for more details [CLICK HERE](#)), speech lessons (LAMDA), activities outside the curriculum (e.g., CCF, Duke of Edinburgh Award Scheme, Cubs, Sea Scouts) and digital devices (see below). VAT will be added where applicable.

Fees charged by external examination boards are added to the fee account in the relevant years.

Extras

Extras are only added to the fee bill with parents' permission and are charged a term in arrears. Trips and Expeditions which are not part of the curriculum are charged at cost and payable in full, usually in instalments, before the trip takes place. VAT will be added where applicable.

Acceptance Deposit

A deposit payment of £2,500 is payable on acceptance of a place. The deposit will form part of the general funds of the School until it is credited without interest to your account on your child's leaving, subject to our notice requirements.

Digital Devices : Thirds (Year 7) Only

We partner with a trusted third-party supplier to provide pupils with access to a standardised digital device during the first three years in the Senior School (Thirds, Removes and Lower 4th – Years 7, 8 and 9). The scheme offers flexible purchasing options via an online portal, including outright payment or instalment plans spread over 12, 24 or 36 months.

Each device includes break/fix insurance that covers accidental damage and theft (excluding loss). Devices will be fully managed by Bancroft's and will have digital safeguarding software installed. This management will remain in place until the end of Lower 4th (Year 9), at which point there may be an option to extend the breakdown cover to enable the device to be used for a further two years.
